 - Per requirements, we performed our annual review of the UW
 Accident Prevention Plan and our Group 9 charter, and we reviewed
 EH&S' annual report to our Executive Sponsor, tracking OARS trends.
 - o Per requirements, we reviewed all OARS reports. Per EH&S recommendation, we started applying the "Five Why's" to one report each month, and completing EH&S' new Slip/Trip/Fall form.
 - We stepped up to school-year evacuation drill scheduling. We tracked our annual building evacuation drill status and reminded members to complete Fire Safety and Evacuation Plans.
 - We followed the output of UWPD's Building Safety Task Force and Facilities' Building Coordinators Guiding Coalition. We forwarded Facilities' reminder that only Facilities should do facilities work. We shared information about UWPD's CPTED security assessments, and the local availability of CERT training.
 - We distributed MyChem lists to each department showing which labs had not updated MyChem in the last year (a compliance reminder).
 - o We reviewed the protocol for L&I or Dept of Ecology surprise visits.
 - o We brought in guest speakers who were content experts from MAPS, Transportation Services, UWPD (a community engagement officer on de-escalation techniques), UWEM (regarding business continuity planning), the CORAL equipment access management system, and various EH&S reps regarding lab safety in shared spaces, fire safety, chemical spill safety, occupational H&S, and the new OARS dashboard. We reviewed Bystander Intervention Training and the Green Dot program.
 - We compared how each department onboards for safety, an exercise that may prove useful to repeat annually.

I will be retaking a rat hands-on course for a refresher on proper rat handling techniques for successful intraperitoneal injection.

Supervisor's Comments Root Causes: (Please look at all the factors that may have contributed to the accident. Such factors may include equipment, environment, policies, procedures, and personnel.) Our Sprague dawley rats are often very docile and used to being handled. It is highly unusual for a postnatal 35 rat to even nibble or nip at a handler. We identified that this rat pup might have been experiencing high stress or anxiety, even with our normal handling techniques. This is the first incident of its kind in 5 years of weekly animal work in my lab, and in my opinion is an isolated incident. Recommendations/Preventive Measures: However, will retake the rats hands-on training just to refresh on handling techniques and will relay any updates to all approved animal users in the lab at our next lab safety moment in lab meeting. 1. Call to Order and Introductions

Leslie Anderson called the meeting to order at 1:06p.m. The Executive Sponsors and their designees introduced themselves: Dave M. Anderson, Executive Director of Health Sciences Administration and HSC 4 Executive Sponsor; Lou Cariello, Vice President for UW Facilities and HSC 2 Executive Sponsor; Susan Wagshul-Golden, Director of Campus Safety, HSC 8 UW Tacoma.

2. Recognition: Leslie Anderson

Committee members recognized Leslie for her over 12 years of service to the safety committees, including two terms as the U-Wide Chair. Leslie thanked the committee and appreciated the opportunity to be passionate about safety at the University.
